# Introduction-

The training of an IAS officer trainee spans about two years and comprises the following courses:

- The Foundation Course –(15 weeks)
- The IAS Professional Course Phase I (52 weeks)
- The IAS Professional Course Phase II (8 weeks)

This entry level training in the Academy is meant to prepare the officer trainees for the first decade of their career when they function as Sub-Divisional Officers, Project Officers of District Rural Development Agencies/ CEOs of Zilla Parishads, Municipal Commissioners, District Magistrates and assignments in Directorates, Public Sector Undertakings and in Secretariats. At a more fundamental level, this training is meant to build a foundation and provide a perspective for the rest of the career of the Officer Trainees in the Indian Administrative Service.

The training modules on gender and development outlined in this booklet are a broad guide to potential trainers of the nature of coverage and scope of sessions expected at the various stages of training outlined above. The contents recommended in these training modules are the result of deliberations of workshops held on 8 – 9 December 2011 & 6- 7 March 2012, by the National Gender Centre, LBSNAA, on Workshop to "Develop Training Modules on Gender", which were conceived and coordinated by Ms Roli Singh, Director, National Gender Centre-NIAR, LBSNAA. The participants represented a vast range of experts from governments (state and national level) training institutions, civil society organisations and UN agencies. The list of participants is attached at Annexure – 1. While the participants recommended subjects to be covered, the actual shape of this teaching material has been formulated , designed and the material supplemented and finalised by Sarojini Ganju Thakur, Senior Gender Expert, NGC-NIAR with Anjali Chauhan, Consultant/Associate Professor, NGC-NIAR, LBSNAA and Rachna Bisht, Programme Associate, UN-Women . This entire process has been supported by UN WOMEN, and special mention deserves to be made of Shri Suraj Kumar, Head – Governance Unit, UN-Women, New Delhi, for his close involvement.

# Tips for facilitators/ trainers:-

• The scope of the session is a broad outline of the coverage expected and is linked to the anticipated learning outcomes from the session.

- To a large extent the resource materials listed are available at the click of a mouse on the relevant hyperlink. However, the resource materials indicated are not comprehensive but are illustrative of the scope.
- To deliver on inputs on some topics/subjects, especially Violence Against Women an integrated approach with inputs from legal administrative (law enforcement machinery), government and non government perspectives would be effective

# **Foundation Course**

The Foundation Course marks the transition from the academic world of the college and university or from the experience of working in a technical field in the private/public sector to working as a general administrator in a structured system of government. For most of the course participants, this course will be their first introduction to government and governance, as also the role of government in the society. The course is designed in a manner so as to achieve the objectives outlined by arranging a combination of academic, outdoor, extra-curricular and co-curricular activities. During this period, the Academy endeavours to provide appropriate training inputs which would be useful to Officer Trainees (known popularly as OTs) in understanding the basic concepts of governance and the rules and regulations which are necessary for effective performance in government. Officer Trainees shall also acquire the personality traits and attitudes necessary for effective functioning.

# **Objectives of Gender Inputs**

The broad objectives of the sessions on gender in the Foundation Course are twofold:-

- Inputs of general nature so as to build or develop a gender perspective. This will
  familiarize all trainees with concepts of gender so that irrespective of the service
  they are allocated they can apply a gender lens.
- Inputs related to law, where the focus would be on gender based violence which is an issue that cuts across personal and professional lives. This would cover different forms of gender bias in legal framework and implementation-
  - Domestic Violence
  - Dowry
  - Sexual Harassment.

## **Getting Started**

In order to meet the learning objectives a minimum of 6 sessions would need to be allocated during the Foundation Course. During the design workshops it was indicated that a maximum of two sessions could be allocated from the 'general' sessions and 4 sessions come within the purview of the Law course for Foundation Course. However, it was felt that if possible allocation of additional sessions would enhance greater self-awareness and a deeper understanding of fundamental gender concepts and issues

# Session 1 & 2 : Building a Gender Perspective ( 2 sessions)

Session 3, 4, 5 & 6 : Gender Based Violence – This would cover its forms and causes, existing legislations and its implementation particularly for

- Domestic Violence
- Dowry/Acid Attacks
- Pre Conception & Pre Natal Diagnostic Test
- Rape and Molestation
- Sexual Harassment
- Khap Panchayats /Honor Killings

This would also introduce the gender bias in legal framework and interpretation , including issues of personal law / inheritance etc., and umbrella of CEDAW.

# SESSION 1 & 2 - Building a Gender Perspective

Time 2 hrs

**Objective** To sensitize participants to gender, the nature of gender inequalities and the

relationship between gender & development

# **Learning Outcomes**

- The trainees will be able to understand the concepts of gender and sex, gender relations, practical and strategic needs and difference between formal and substantive equality
- Trainees will understand the nature of gender inequalities in the various institutions, access and control of resources, entitlement / rights and empowerment
- Why gender is a developmental issue?

## **Scope of the Session**

- Distinction between sex/ gender with definitions/illustration
- Gender inequalities in household, community, workplace and state
- Understanding the normative basis for the above, access to and control of material social, economic and political resources, gender relations and power relations, the difference between practical gender needs and strategic gender interests
- Gender and development -the rights based and instrumental rationale for gender equality, and the distinction between formal equality and substantive equality

- Ball Game :- in view of large number and to keep attention focus on subject, we have a ball where the facilitator draws up the list of quotes to gaze present sensitivity and knowledge on gender :-

(What was the time when you felt you are treated differently?)

(What things made you realise that you are different from the other sex)

- Role Play:-the facilitator can identify a few trainees to do a role play on various subjects such as :-

- (c) Quiz:-Based on Census data, NSO data, education survey, NFHS data etc on differences in attainment of men and women in survival, longevity, education, employment, heath, a quiz can be made.

**Objective:** to understand gender based violence, its forms and causes

Time: 4 hrs

The participants will enhance awareness/knowledge on gender based violence, their forms and causes and impact.

- Causes of Gender Based Violence and focus on Sexual harassment, domestic violence.

## Films:

 Nasreen O Nasreen- 28 mts- this film is based on the work of Delhi's NGO Shakti Shalini. The organisation does counselling for women facing violence and helps them by providing other services also. This film is based on the real life situations of women. It shows that irrespective of class, caste, religion and age, women could face violence.

- Saving Face is a documentary film about acid attacks on women. The film has been awarded the 2012 Academy Award for Best Documentary (Short Subject), making its director, Sharmeen Obaid-Chinoy, Pakistan's first Oscar winner. The film follows London-based Pakistani plastic surgeon, Dr. Mohammad Jawad, as he journeys to Pakistan to perform reconstructive surgery on survivors of acid violence. Saving Face also broaches the subject of the under-reporting of acid violence against women due to cultural and structural inequalities towards women from Pakistani men. The film also features two women attacked by acid and their struggle for justice and healing. The Acid Survivors Foundation of Pakistan, which is featured in the film, had documented over 100 acid attacks a year in Pakistan but estimates far more due to lack of reporting. The film is "a positive story about Pakistan on two accounts: firstly, it portrays how a Pakistani-British doctor comes to treat them and it also discusses, in great depth, the parliament's decision to pass a bill on acid violence". The film assisted in the trial and conviction of one of the perpetrators of acid violence on a female victim.
- Man ke Manjeere :- 5 mts An Album of Women's Dreams, which has, focuses on promoting women's rights and bringing attention to domestic violence. The aesthetically and emotionally powerful music video was shot by Sujit Sircar and Gary and tells the true story of Shameem Pathan, who courageously broke out of her abusive marriage and became a truck driver to support herself and her child away from her violent husband. The Hindu described the impact of Mann ke Manjeeré saying, "Mann ke Manjeeré has made a breakthrough by claiming public space for women's aspirations."
- **Bhawandar** is a 2000 <u>Indian</u> film, based on the true story of <u>Bhanwari Devi</u>, a rape victim from <u>Rajasthan</u>, India. The film depicts the personal trauma, public humiliation and legal injustice that Bhanwari Devi went through, while pursuing justice in the Indian courts.

## Phase – I

Phase-I is the first Professional Training Course conducted for the IAS and imparts rigorous training to the IAS Officer Trainees in a wide range of subjects to enable them to handle varied assignments that the officer typically holds in the first decade of service. It is of six months duration. There will need to be a minimum of three sessions specifically attributed to gender and development, but apart from this gender will be mainstreamed in each of the modules throughout the training. The inputs suggested in the individual modules are to supplement the general overview and exposure to the subject in order to clearly highlight the different roles and responsibilities of men and women, and the need for gender responsive governance.

- Nasreen O Nasreen- 28 mts- this film is based on the work of Delhi's NGO Shakti Shalini. The organisation does counselling for women facing violence and helps them by providing other services also. This film is based on the real life situations of women. It shows that irrespective of class, caste, religion and age, women could face violence.
- Saving Face is a documentary film about acid attacks on women. The film has been awarded the 2012 Academy Award for Best Documentary (Short Subject), making its director, Sharmeen Obaid-Chinoy, Pakistan's first Oscar winner. The film follows London-based Pakistani plastic surgeon, Dr. Mohammad Jawad, as he journeys to Pakistan to perform reconstructive surgery on survivors of acid violence. Saving Face also broaches the subject of the under-reporting of acid violence against women due to cultural and structural inequalities towards women from Pakistani men. The film also features two women attacked by acid and their struggle for justice and healing. The Acid Survivors Foundation of Pakistan, which is featured in the film, had documented over 100 acid attacks a year in Pakistan but estimates far more due to lack of reporting. The film is "a positive story about Pakistan on two accounts: firstly,

it portrays how a <u>Pakistani-British</u> doctor comes to treat them and it also discusses, in great depth, the <u>parliament's</u> decision to pass a bill on acid violence". The film assisted in the trial and conviction of one of the perpetrators of acid violence on a female victim.

- Man ke Manjeere: 5 mts An Album of Women's Dreams, which has, focuses on promoting women's rights and bringing attention to domestic violence. The aesthetically and emotionally powerful music video was shot by Sujit Sircar and Gary and tells the true story of Shameem Pathan, who courageously broke out of her abusive marriage and became a truck driver to support herself and her child away from her violent husband. The Hindu described the impact of Mann ke Manjeeré saying, "Mann ke Manjeeré has made a breakthrough by claiming public space for women's aspirations."
- **Bhawandar** is a 2000 <u>Indian</u> film, based on the true story of <u>Bhanwari Devi</u>, a rape victim from <u>Rajasthan</u>, India. The film depicts the personal trauma, public humiliation and legal injustice that Bhanwari Devi went through, while pursuing justice in the Indian courts.
