**Sub:- Preliminary scrutiny of the applications received from the dependent family members of the deceased Government servant for appointment on compassionate grounds, up to the last date i.e. 10.11.2025**

The Policy for Consideration of appointment on compassionate Ground in LBSNAA (Relative Merit Point System and Procedure for selection) published vide Office Order no. 18 dated 10th January, 2025.

2. In pursuance of the above policy, a notice dated 25.09.2025 was issued through the website, notice board, and e-mail of LBSNAA, inviting applications and supporting documents from the spouse/one eligible dependent family member of deceased Government servants who were working in LBSNAA, for filling up two (02) posts of MTS (Group 'C') on compassionate grounds in the Academy.

3. The last date for submission of applications along with supporting documents was 10.11.2025 by 05:30 p.m. A total of eight (08) applications, as detailed below, were received by the last date. On preliminary scrutiny of the applications, it has been observed that certain information required for allotting points to the candidates has not been furnished or is not clearly mentioned in the application forms submitted by them. \*In terms of para (2) of DoPT's OM dated 2nd August, 2022 (Master Circular on the Scheme of Compassionate Appointment), a dependent family member may apply for appointment on compassionate grounds. Further, as per point (13) of DoPT's FAQs dated 30th May, 2013, a married son is not considered dependent on a Government servant. Accordingly, Shri Abhishek Kumar S/o Lt. Ramji (Sl. No. 4) is not eligible, as he was already married on the date of demise of his father.

4. On approval of the committee, all the above candidates are advised to submit the information/documents on an affidavit, within 10 days from the date of issue of this notice.

5. Shri Abhishek Kumar, S/o Lt. Ramji is further requested to clarify his marital status as indicated in Sl. No. 4 of Para 3 above in person with relevant proof as per rules.
