**Subject:** Filling up one post of Data Processing Assistant in the LBSNAA Mussoorie on deputation (including short term contract) basis.

Application are invited for filling up one post of Data Processing Assistant (General Central Service, Group 'B', Gazetted, Non-Ministerial) in Level-7 (Rs 44900-142400) in the Pay Matrix in the Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie, District Dehradun **on Deputation (including short term contract) basis**. Eligibility conditions *i.e.* educational and experience qualifications, period of deputation etc. are indicated below:-

**Pay level:** Level-7 (Rs.44900-142400 in the pay matrix).

**Eligibility:** Officers of the Central Government or State Governments or Universities or Recognised Research Institutions or Public Sector Undertakings or Semi-Government or Statutory or Autonomous Organisations:-

- a) (i) Holding analogous posts on regular basis in the parent cadre or Department; or  
(ii) With five years' service in the grade rendered after appointment thereto on regular basis in posts in Pay Level-6 (Rs. 35400-112400) in the pay matrix; and
- (b) Possessing the following educational qualifications and experience:

**Essential qualifications:**

- (i) Master's Degree in Computer Application or Information Technology or Computer Science of a recognized University or Institute ; or  
(ii) Bachelor of Engineering or Bachelor of Technology in computer Engineering or Computer Science or Computer Technology or Computer Science and Engineering or Information Technology from a recognized University or Institute.

**Period:** The period of deputation (including short term contract) including the period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department in the Central Government shall not exceed three years.

**Duties and responsibilities of the post include:-**

To look after all matters pertaining to reprographic work, maintenance of equipments, etc., provide software/hardware information and performing technical support services for computer users; and any other related work as may be required from time to time.

**Regulation of Pay and other terms of deputation:** The pay of the selection candidate will be regulated under the provision contained in the DoPT O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended time to time.

**Age Limit:** The maximum age limit for appointment on deputation (including short-term contract) shall not exceed (fifty-six) 56 years as on the closing date of receipt of application.


The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
