1. Centre for Cooperatives & Livelihood Activities for FY 2023-2024:

The members engaged in a comprehensive discussion about the activities to be planned by the Centre for Cooperatives & Livelihood (CCL) for the financial year 2023-2024. Various proposals and initiatives were presented and evaluated to promote the overall objectives of CCL, which include fostering cooperative development, livelihood enhancement, and sustainable rural development.

- 1. The following activities were finalized for implementation during FY 2023-2024:
- a. Training Programs: As per the MoU signed between CCL, LBSNAA and NAFED and agreed upon to conduct specialized training programs for Senior NAFED Officials to enhance their skills in cooperative management, entrepreneurship, and sustainable livelihood practices.
- b. Livelihood Projects: 14 IAS (Probationers) of 2021 Batch from different district/ states have undertaken the livelihood projects in their respective district in collaboration with Centre for Cooperatives & Livelihood and District Administration to identify the product (s) from their district for production, marketing, sale and for research and development, capacity building, and any other activities related to the project.
- c. Workshops and Seminars: It was plan to organize workshops and seminars to facilitate knowledge sharing, best practices, and discussions on pertinent topics related to cooperatives and livelihoods.
