

## Land Administration Module under IAS Professional Course Phase I (2023 Batch)

B N Yugandhar Centre for Rural Studies organized 03 Days Land Administration Module under the IAS Professional Course Phase I (2023 batch) during 18-20 March, 2024. The Land Administration Module provided training inputs on general overview of Land Administration; Major Acts in the Land Administration and recent schemes of Department of Land Resources, Government of India including DILRMP, NGDRS, ULPIN as well as other aspects of Land Administration and Management.

As a part of this module, the centre prepared a booklet containing relevant reading materials for the reference of the IAS Officer trainees on various issues such as Historical Perspective of Land Administration, Current Programmes & Concerns, Key revenue functions and revenue terms.

The training module on Land administration included sessions by key resource persons on SVAMITVA, RFCTLARR Act, DILRMP, Revenue Court Case Monitoring System, land resurvey, modern land survey techniques and interface of land issues between revenue and forest departments. Land being a state subject, state specific understanding of land laws, historical perspective of tenurial system, modern land administration and management are the basic learning aspects for the Officer trainees. 23 breakout sessions were conducted to reinforce the state specific learning outcomes on land revenue and administration of different states for the Officer trainees of different cadres. Further, a Hands-on Training of traditional and modern survey technology to sensitize the IAS Officer trainees with methods of land survey.

The day wise activities under the Land Module are as follows:

**Day I** comprised of General overview of Land Administration, Major Acts in the Land Administration and recent schemes of Department of Land Resources, Government of India includes DILRMP, NGDRS and ULPIN.



**Day II** of the module includes Survey methods including the Hands-on Training on the Land Survey Techniques with the Support of Survey of India, Dehradun and the Field Survey Team from District Administration, Dehradun. The sessions on RFCTLARR and Land Resurvey were also conducted.



On **Day III**, Cadre wise Land Administration module was conducted for deep-understanding of their State/Cadre specific land laws and practices. The Resource persons covered the core issues of land administration, such as; history of land administration, administrative set-up, land revenue and reforms Acts, basic tenets of land administration, SDM/DM role and responsibilities in land management, best practices and other relevant issues pertaining to land administration. 22 State wise cadre and 3 UTs in AGMUT supported in nominating resource persons for the Cadre wise sessions.



The Land module was completed by conducting an assessment of learning outcomes through a set of multiple choice Questions as per the standard procedures followed in the Academy.

## **Agriculture and Rural Development and Panchayat Raj Module under IAS Professional Course Phase I (2023 Batch)**

B N Yugandhar Centre for Rural Studies organized the 03 Days Agriculture, Rural Development & Panchayati Raj Module under the IAS Professional Course Phase I (2023 batch) during 04-06 March, 2024. The Agriculture, Rural Development and Panchayati Raj Module had provided training inputs on input management and risk management in agriculture and allied sectors, FPOs, income approaches to agriculture and major flagship schemes of Ministry of Rural Development.



As a part of this module, the centre prepared a booklet containing relevant reading materials for the reference of IAS Officer trainees on various issues such as agricultural development since independence, administrative set-up and schemes of agriculture and allied departments in states, case studies on natural resource management, agricultural marketing, returns from agriculture and agricultural extension.

The training module comprised major topics related to agriculture including input management, risk management, MSP and procurement, FPOs, horticulture and fisheries sector (present and future prospects), livestock husbandry (status, challenges and prospects), farmer mobilization and agriculture value chain, and Doubling Farmers Income: An Income Approach to Agriculture. Further, in Rural Development and Panchayati Raj, major flagship schemes were covered including MGNREGA – Opportunities and Challenges, Jal Jeevan Mission, Watershed Management and River Rejuvenation and Janandolan.
